

How to submit a claim?



- What does "Buyer details" mean?
 These are the details of your customer.
- Should "Gross Amount" include VAT? Yes.
- What does "Document Number" mean?
 This means the Invoice Number.

What is next?

Our Claims & Collections (C&C) team will review your claim and will:

- 1. Acknowledge receiving your claims within 2 working days
- 2. Request missing documents, if any
- 3. Provide preliminary decision with 30 days from the day we receive all the required documents
- If you don't have inclusive collection in your policy, you have to continue to mitigate your losses by taking necessary collections/ legal actions.
- 5. Settle the balance of your valid claims within 30 days from "the day of Loss" (Protracted Default PD) or insolvency.
